The Fresh Films website (the “Site”) is an interactive website owned and operated by Dreaming Tree Foundation dba Fresh Films, (“Fresh Films”), a nonprofit film producer who engages youth in the fun and relevancy of film to grow confidence, build skills in technology, expose youth to STEAM careers and develop 21st century skills like problem solving, communication and teamwork.

By using the Site, you are agreeing to the following terms and conditions. These terms and conditions shall constitute an agreement (the “Agreement”) between you and Fresh Films governing your use of the Site. Please read these terms and conditions carefully before using the Site.

By using the Site and/or submitting projects, you represent and warrant that you have read, understand, have the legal capacity, and agree to be bound by these terms and conditions.

Changes to this Agreement

Fresh Films reserves the right, at its sole discretion, to change, modify or otherwise alter these terms and conditions at any time. It will post the most recent version of these terms and conditions on this website with a date indicating when changes were last made. Any modifications shall become effective immediately upon the posting thereof. Please check for updates each time you use the Site to keep apprised of any changes. Your continued use of the Site following the posting of modifications will constitute your acceptance of the revised terms and conditions.

Consent to Communications

Digital Millennium Copyright Act

Fresh Films expressly prohibits the use of the Site for the illegal transmission of copyrighted material, and will respond if notified by content owners to prevent copyrighted material from being transmitted via the Site.

If you believe that your work has been copied in a way that constitutes copyright infringement, please provide Fresh Films the written information specified below:

1. An electronic or physical signature of the person authorized to act on behalf of the owner of the copyright interest;
2. A description of the copyrighted work that you claim has been infringed upon;
3. A description of where the material that you claim is infringing is located;
4. Your address, telephone number, and e-mail address;
5. A statement by you that you have a good-faith belief that the disputed use is not authorized by the copyright owner, its agent, or the law;
6. A statement by you, made under penalty of perjury, that the above information in your notice is accurate and that you are the copyright owner or authorized to act on the copyright owner's behalf.
