2023-2024 FRESH FILMS Educator Grant Sweepstakes Promotion Official Rules

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN

- 2. To enter: The Fresh Films Educator Grant ("Educator Grant") Sweepstakes Promotion ("Promotion") begins March 24, 2023 and runs until 6 weeks after the last Industry Insights video is released (the "Promotion Period"). The Promotion is open to classroom-based educators teaching 6th to 12th grade who have access to the Educator Grant electronic entry form provided by Fresh Films. Educators can enter multiple times during the promotional period but will only be eligible to win a maximum of (1) one grant. Entries must be received electronically via Fresh Films portal located at https://freshfilms.org/educators/. The application application page (linked from the URL) consists of watching the episode, answering specific question and providing relevant contact information
- 3. Eligibility: Legal residents of the United States are eligible to participate and win. In order to win, the entrant must be currently employed as a teacher, a counselor, or a similar classroom-based position at a public or private school district serving 6th to 12th grade students. Employees of Fresh Films, its subsidiaries and the immediate family of any such persons (spouse, parents, siblings, and children and each of their spouses) and persons living in the households of each of these individuals, whether related or not, are ineligible to enter and win. Individuals who have won a previous Educator Grant in the current year or previous two years are not eligible to win.
- 4. Drawing: A random drawing will be conducted 3 weeks after the close of the entry period shown on Fresh Films' website https://freshfilms.org/educators/. Up to 14 winners will be selected for Season 2. Winners will be notified via email at the email address provided on the entry form.
- 5. Prize: Each winner will be awarded a \$300 check payable to the school they are employed at to buy classroom materials. Eligible winners will be randomly drawn from qualifying entries in Fresh Films' sole discretion. \$3,300 will be awarded in total. No prize is transferable. The winner is solely responsible for reporting and paying applicable state and federal taxes. The winner must provide Fresh Films with a signed winners affidavit (provided by Fresh Films to winners).
